RENTAL AGREEMENT

1. **The Renter** agrees to pay additional invoices for pre-approved perishable items upon receipt of invoice. All perishable items, including but not limited to batteries, gaffers tape and microphones for wireless transmitters, must be purchased separately and are not part\ of the rental package.
2. **INSURANCE:** Certificate(s) of Insurance must be received by close of business – at least 2 business days prior to the ship date. Certificate(s) of Insurance must list **One Dream Sound Corporation** as an additional insured for general liability and as a loss payee for the value of the equipment provided. **The Renter** is responsible for all balances due which are not covered by insurance. **Total Insurance Value: \$169,263.55**
3. During the term of the rental and at all times when the equipment is in the custody and control of the **Renter**, the **Renter** shall maintain the equipment in good condition and repair. At the end of the term hereof, or at its earlier termination, the **Renter** shall, at its cost and expense, return the equipment to **One Dream Sound Corporation** in good condition and repair, reasonable wear and tear excepted, by the terms of shipping stated above.
4. **The Renter** hereby assumes full responsibility for the equipment rented and agrees to compensate **One Dream Sound Corporation** to the extent of the full value should any item of said equipment not be returned or be returned in a damaged or broken condition, due to any cause whatsoever. The **Renter** agrees to return all items in same condition as received. **One Dream Sound** must be notified of any existing damage within 24 hours of receipt of goods. Otherwise, damage will be presumed to have occurred in the **Renter's** possession. The **Renter** further agrees to compensate **One Dream Sound Corporation** rent for any time lost as a result of replacement, or if **One Dream Sound Corporation** has to make repairs to broken or damaged equipment, unless such replacement or repair is caused by any failure of the equipment.
5. Rental of all equipment must be paid for the period of time it is in the **Renter's** custody and until it is returned to **One Dream Sound Corporation**. No allowances will be made for unused equipment.
6. **The Renter** assumes all risk in the use and operation of the rented equipment, and shall be responsible for providing proper safety devices and equipment to safeguard users and operators of the equipment herein rented, and for installation of the equipment in safe and adequate facilities, in order to comply with all Federal, State and Local laws.
7. **Ladders and lifts Hold Harmless Agreement-** If this order includes ladders or lifts (including personnel lift(s) and/or equipment lift(s)): I/We (_____) (Client name) understand that the use of and proximity to the use of such equipment carries with it the potential for certain risks, some of which I/we (client) may not reasonably foresee. I/We Further acknowledge the these risks could cause the user, or others around the user, harm, not limited to bodily injury, damage to property, emotional distress, or death. I/We understand that risks exist and I/we choose to enter into this agreement to use said equipment freely and without reservation. By signing this agreement, I/we agree to release, indemnify, and hold harmless One Dream Sound Corp., as well as all its employees, agents, representatives, successors, etc. from all losses, claims, theft, demands, liabilities, causes of action, or expenses, known or unknown, arising out of my/our use of ladders or lift equipment supplied by One Dream Sound.

8. It shall be lawful for the owner or its agents, at all reasonable times and with advance notice, to enter the premises where the equipment is kept for the purpose of viewing the condition of said equipment.
9. If the **Renter** shall default on any of the terms, covenants and conditions herein, or in punctually making any rental or other payment, or if any execution or other writ or process shall be issued in any action or proceeding against the **Renter**, whereby the said equipment may be seized or taken, or if a proceeding in bankruptcy, receivership or insolvency shall be instituted by or against the **Renter** or his property, or if the **Renter** shall enter into any arrangement or composition with his creditors, or in the event that any judgment is obtained against the **Renter**, then and in any such event, **One Dream Sound Corporation** shall have the right to terminate this agreement and retake immediate possession of said equipment and, for such purposes, **One Dream Sound Corporation**, its agents or employees, may enter upon any premises where said equipment may be, and may remove the same therefrom, with or without notice of intention to retake the same, without being liable in any suit, action or other proceeding by the **Renter**.
10. The equipment is and shall remain at all times the sole and exclusive property of **One Dream Sound Corporation**. The **Renter** agrees not to remove or cover the tag or nameplate on the equipment showing ownership by **One Dream Sound Corporation**.
11. The return of the rented equipment is not a waiver by **One Dream Sound Corporation** of any claims that it may have against the **Renter**, nor a waiver of claims for latent or patent damages to the equipment.
12. In all programs of production in connection with which the property and materials above set forth shall be used, where applicable, credit shall be given in the form of "Sound Equipment by One Dream Sound".
13. Any labor quotation included in this agreement is an estimate only and therefore subject to change as the production evolves. Any additional labor charges will be billed to the **Renter** no later than 48 hours after the completion of the load out.

The **One Dream Sound** crew chief is required to receive written authorization from the **Renter** if the production crew is about to enter either a meal penalty or overtime billing period beyond what is included in this contract. Overtime and meal penalty work will not be permitted to commence until such written authorization has been received.

Overtime shall be paid after ten (10) hours in a day or for any breached meal period. Meal periods shall be given no earlier than before the third hour of work or no later than the beginning of the sixth hour of work, concurrently. Overtime shall be paid between midnight and 8:00 am, and on Sundays. -
